APPLICATION PROCESS

TERMS AND CONDITIONS

To apply to be considered as a SATUC World Cup Team, the following must be submitted an application electronically and in original form by normal postage:

A signed application letter addressed to SATUC, containing:

1. Last financial position of the institution and activity report.
2. institution registration documents.
3. Your organisation's name, address, country, email, phone number, and a certificate proving that you are a charitable organisation;
4. Your organisation's purpose/mission statement.
5. A confirmation statement that your Organisation will provide a Team to participate in the Tournament.
6. Your organisation's logo (in the form of a high-resolution jpeg).
7. A detailed biography of your organisation.

Accepted Teams must submit all the required at least 3 months before the Cup deadline, for any emergency changes to the Participants. The Team itself will incur the financial costs of any changes to the Participants after this date. It is imperative that we receive all of the above without delay as we are a non-profit organization organizing flights and accommodation for a huge number of people, so with your cooperation, we can arrange everything efficiently and in plenty of time.

Accepted Teams must submit:

- Age and passport data form signed by coaches, guardian and board members of the organization.
- Completed Team Measurement Forms. (word format)
- Regulations signed by coaches, guardian and board members of the organization.
- SATUC Assoc declaration form signed by coaches, guardian and board members of the organization.
- The names of the final 8 players as shown in their (passport/passport number/country and the charitable name/ Roll Player/age). (word format)
- Passport photocopies of each of the Participants and confirmation of all of their names as shown on their passports and as given at the start of the photocopies of the passports and visas for all the Participants.
- Co-operation between the charities.
- Brief biographical information about each Player.
- A certificate showing that an appropriate adult has interviewed the player and believes them to be physically and mentally fit and sufficiently mature and stable to travel outside of his home country.
- Individual and Group photographs (in the form of high-resolution jpeg.) of all the Participants and with a statement that grants SATUC permission to use the images on our website and other promotional material;
- Individual photographs and names (in the form of high-resolution jpeg.) of all Players and with a statement that grants SATUC permission to use the images on our website and other promotional material.

TERMS AND CONDITIONS

DEFINITIONS

- The match means an official 5-a-side football match that is authorised by the SATUC organisation. (venue and date TBC) under the name of the SATUC World Cup.
- Team means a total of 8 Players (consisting of 5 starting players and 3 substitutions) and 2 Coaches to be formed by a charitable Organisation or similar institution.
- Player means a male child below the age of 15 representing a country at the SATUC Cup.
- Participants mean Players and Coaches male.
- Coaches' means 2 male persons over the age of 18 years who are wholly responsible for the behaviour and safety of the players both before and during the course of the tournament.
- Media Representative means members of the media from each participating country authorised and approved by the Organisation to attend the tournament. Accommodation and flight will not be provided for these members at the SATUC events.
- Training Camp before travelling to hosting country: an organised and structured football training event that must take place over a minimum of 31 days.
- Training Camp during the time at hosting country: an organised and structured football training event that must take place over a minimum of 2 days.
- Partner means a charitable Organisation or similar institution that has been accepted by the Organisation to provide a Team for the Tournament.
- Trophy means the SATUC World Cup trophy will be given to the winning team during the closing ceremony only and other mini trophies will be awarded to the overall winners.

ELIGIBILITY

TERMS AND CONDITIONS

- Players must be male.
- On the final day of the Tournament, no Player may exceed the age of 14 years and 364 days.
- Each Player must be eligible under the FIFA Regulations to represent their country.
- Without the consent of the Organisation, no Player may be a member of any footballing academy or similar institution.
- Players must be sufficiently fit, and not suffering from any health problems that can be exacerbated by exercise.
- Participants recognise that by participating in this event they run the risk of personal injury and even death. Participants confirm that they are aware of and accept such risk and will be responsible for their own actions and involvement in the Tournament.

RULES

TERMS AND CONDITIONS

- The players must meet the following criteria:
- Teams will be made up of 8 players. 5 of them will be playing on the pitch and the other three will be on the bench (so that they can be switched with the players playing the match).
- The matches will not start without the 4 players and goalkeeper.
- Each Match will be 30 minutes in length, divided into two 15-minute halves.
- The winning team gains three points and in the case of a tie, they get one point only.
- Players will not be permitted to play in a third match if they receive two yellow cards in the previous two matches.
- U15 level – means that the players must be less than 15 during the tournament: born December 2002 or later.
- SATUC aims to help disadvantaged and orphaned children, and accordingly, the players selected must meet either one of these criteria. We expect participants to observe the spirit of SATUC, which is to prioritise children who do not have other means of support.
- Players must be citizens of the same nationality as that which their respective charity is representing.
- The SATUC World Cup will be U15 5-a-side – indoors/outdoors. 8 players and 2 Coaches must be selected by each participating charity.
- Only 1 team will be accepted from each country, which should be selected on ability (Assuming the eligibility criteria are met) using a fair selection process.
- All papers and letters requested by SATUC must be sent by the charities and must be appropriately certified by the appropriate governing body of the corresponding countries.
- The players must not smoke at all during the SATUC World Cup.

BEHAVIOUR

TERMS AND CONDITIONS

- Participants must maintain the highest standards of behaviour at all times.
- Participants will not act in a way that will disturb, inconvenience, or compromise the safety or general wellbeing of other participants, SATUC staff, or members of the local community.
- Participants must communicate with each other in a polite and courteous manner.
- Participants must treat each other fairly and without discrimination in a manner appropriate to a peaceful international event.
- Participants must respect each other's diverse backgrounds, cultures, politics, religious beliefs and practices.
- Participants must not use, possess or hold during the course of the tournament:
 - Any item that could be used as a weapon, cause damage and/or injury or be used as a projectile;
 - Any illegal or illicit substances not just limited to narcotics (this includes tobacco and alcohol);
 - Any items that increase the risk of fire or are harmful to health, including but not limited to, lighters, matches, fireworks or other pyrotechnics; or
 - Any other object that could compromise public safety and security and/or harm the reputation of the event.
- Participants must abide by the schedule of the Tournament at all times as specified by the Organisation.
- Without the consent of the Organisation, Participants must not wear any item of clothing other than those specified by the SATUC Organisation since the moment they take off from their home country to the SATUC cup hosting country.
- Other than SATUC's and partnering charities' logos, no flags, banners or signs may have displayed at the Tournament, without the full official consent of SATUC's Board of Directors.
- Participants must not use the swimming pool.

COSTS

TERMS AND CONDITIONS

- The Organisation will cover the costs of flights and accommodation for participants. Please take note of the following:
- Flights will be economy class and may involve stopovers;
- A minimum of 4 participants will be booked into each hotel room. This may be a combination of players and coaches from different countries.
- The Organisation will provide food and beverages for Participants during the course of the Tournament.
- The Organisation will provide match clothing and equipment for the Participants.
- The Organisation will cover the costs of any cultural tours scheduled by the Organisation for the Participants.
- The Organisation will arrange for reasonable insurance cover for the Participants at the Tournament.
- The Organisation will not cover the costs for any passport or visa fees.
